The **ENC-1 Safety Enclosure** is designed to provide external protection to Time Mark's socket-mounted devices.

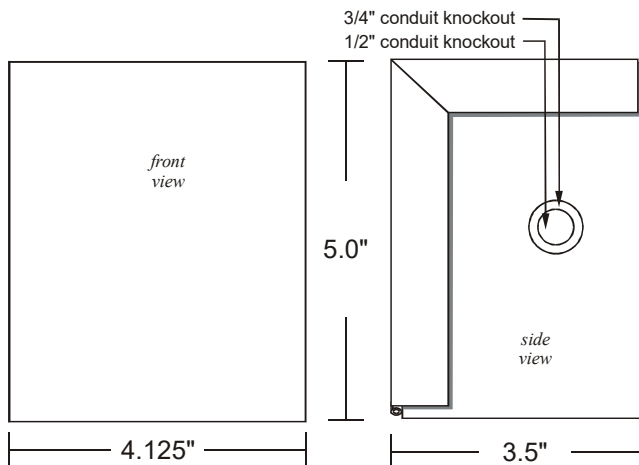
The enclosure is made of 20 gauge steel with a gray finish. Half-inch conduit and three-quarter inch conduit knockouts are provided on three sides.

A standard 8-pin socket is premounted inside the enclosure. The door is hinged to allow easy mounting and access.

INSTALLATION

The Safety Enclosure is a 20 gauge steel case. Inspect all wiring and terminal connections for exposed conductors, loose connections, and pinched wires. Follow all instructions and apply power.

ADJUSTMENT

No calibration or adjustments are needed for the Safety Enclosure.

TROUBLESHOOTING


If the installed unit fails to operate, check all connections. Verify that power is present, and check all fuses. Recheck the installation instructions for the installed unit. Should problems persist, contact the factory at 800-862-2875 for assistance.
